CAPE-Fee Structure for B.Tech Course in the Engineering Colleges under CAPE during the Academic year 2024-25-Revised - Orders issued.

The 185th Executive Committee Meeting held on 20.03.2024 has resolved (item No. '183.4.16) to approve introduction of uniform fee of Rs. 45,000/- to all Non-KEAM lapsed seats, except in the branches of Engineering where Merit full fee category (Management quota Seats) are available. If there is merit full fee category available, then fee of Non-KEAM candidates is to be retained as Rs. 65,000/- common for Merit full fee category (Management Seats) as well as for Non-KEAM candidates. Also it is approved to increase Merit fee (regulated) from present rate of Rs 35,000/- to 40,000/- and to introduce uniform fee Rs.1 lakh for NRI seats of all branches. Accordingly proposal has been submitted to Government for approval.

Government as per GO read as 2nd paper above have accorded sanction for introduction of revised fees structure in respect of students admitted under B.Tech Course during the academic year 2024-25 onwards in the Engineering Colleges under CAPE as detailed below:
